Release and Waiver Agreement for Doggy Dynasty and Matthew Cochran

NOTICE: Please read this document in its entirety before signing. Signing this document affirms that you have read and understood it completely. If you have any questions, please ask before signing.

This RELEASE of LIABILITY is made and entered into on this ____ day of _____, 20____, by and between Matthew Cochran, designated Trainer, and _____, designated Handler, if Handler is a minor, Handler's parent or guardian, _____. In return for the use, today and on all future dates of the property, facilities and services of Matthew Cochran, the Handler, his heirs, assigns, and legal representatives, hereby expressly agree to the following:

1. Handler agrees that their participation in their dog(s)'s obedience training is not without risk to themselves, members of their family, guests who may attend, or their dog(s). Some of those risks include, but are not limited to, risk of illness, falls, bites, injury, or disease through contact with other participants, their dogs, or surroundings. Some of the dogs that the handler will be exposed to may be difficult to control, and, as a result, may be the cause of injury and/or damage, even when handled with the greatest amount of care. Handler agrees that their participation, attending family members/guests, and their dog is voluntary and that each person hereby expressly agrees to waive, release, discharge, and hold harmless Doggy Dynasty, its employees, members, trainers, assistants, volunteers, and/or agents, (hereinafter referred to as the "trainer"), and the owner(s) of the premises, All Pets Considered/Puppy Playschool, from any claims, demands, injuries, damages or causes of action that are in any way related to participation in the class, even though such liability may arise out of negligence or carelessness on the part of the persons named in this waiver and all liability for injury and/or damage which they, their family, their guests, or their dog may suffer, including, but not limited to, any injury or damage resulting from the action of any dog(s) in the training session or on the training grounds. Doggy Dynasty makes no representations, guarantees, implied or expressed promises that the training received during dog training classes from Doggy Dynasty will cure a dog of any dangerous propensities. The Handler also agrees to conduct themselves in a courteous, respectful and dignified manner toward the trainers and other students in the class.
2. In addition, Handler expressly assumes the risk of such injury or damage while attending any training session, any other function of the trainer, and/or while on the training grounds or surrounding areas thereto. Handler also affirms and has proof that their dog is current on all vaccinations appropriate for their dog. Handler agrees to abide by all rules presented during class. Handler also understands that Doggy Dynasty may use for publicity or promotional purposes, their first name and pictures of them or their dog without liability or obligation to Doggy Dynasty.
3. Lastly, Handler hereby agrees to indemnify, compensate, and hold harmless the trainer and the owner(s) of the premises, from any and all claims asserted against the aforementioned, made by any person(s) accompanying them, or, any other person(s) attending any training session and/or other function of the trainer, or while on the training grounds or surrounding areas thereto, as a result of any action by and dog(s), including their own, that causes injury and/or damage.

To the best of my knowledge, all the information requested has been provided accurately and completely. The handler of this dog is responsible for controlling the dog at all times during the class, both during the training sessions and on the grounds where the training sessions are held. A dog and handler may be removed from class at the instructor's discretion should the handler be unable to control the dog.
